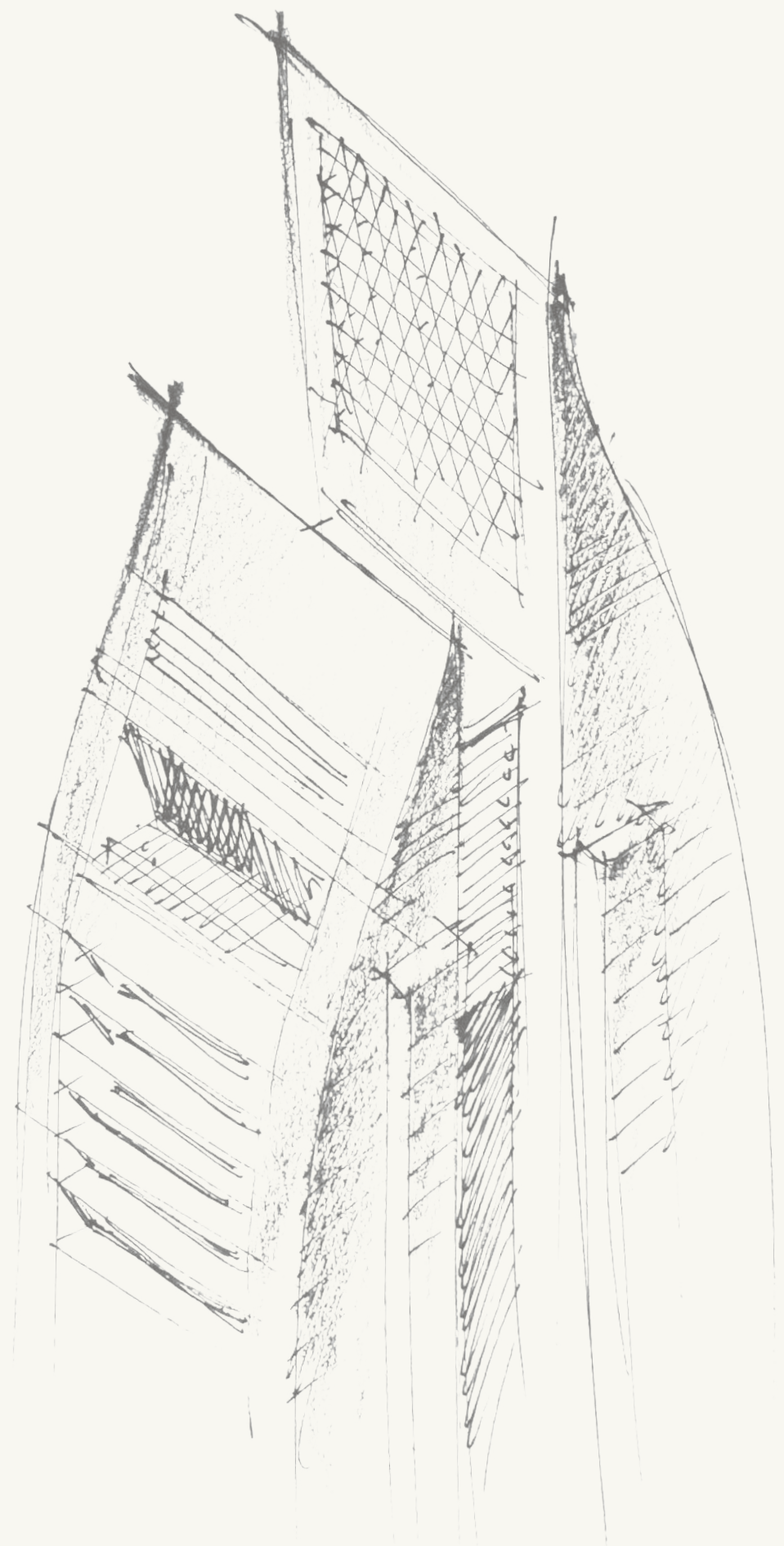

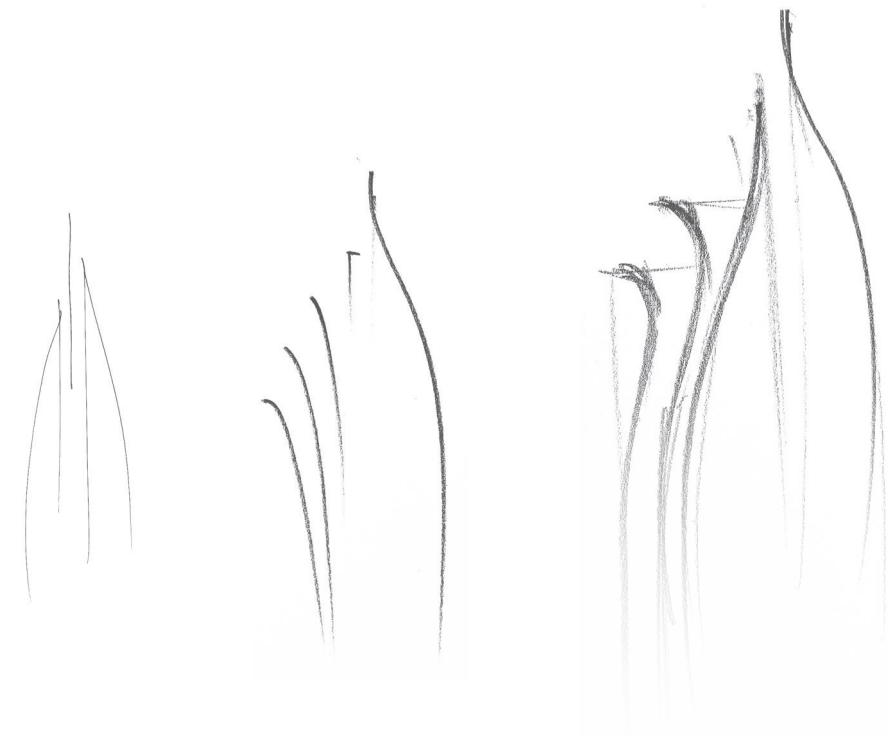
DESIGN

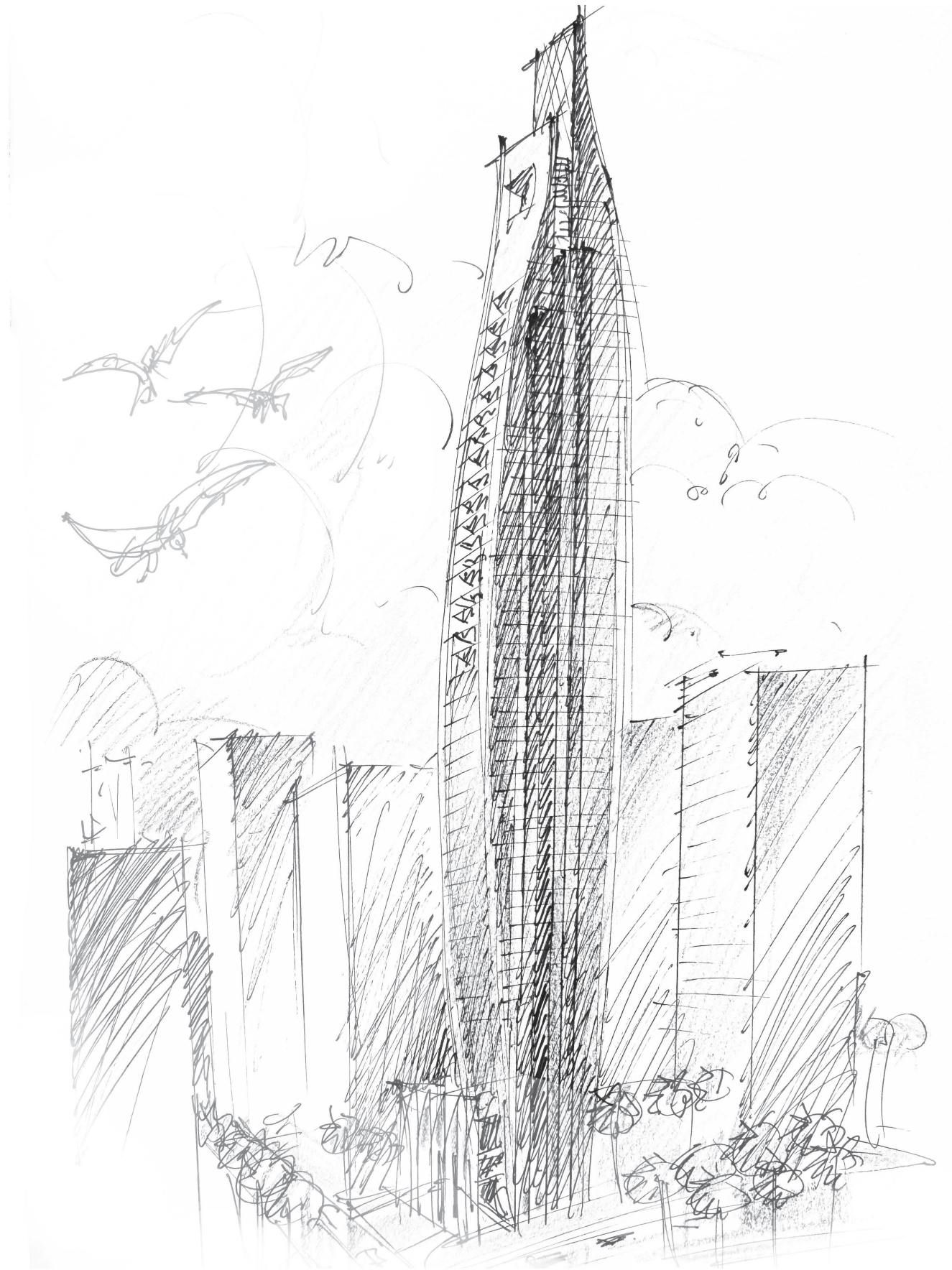

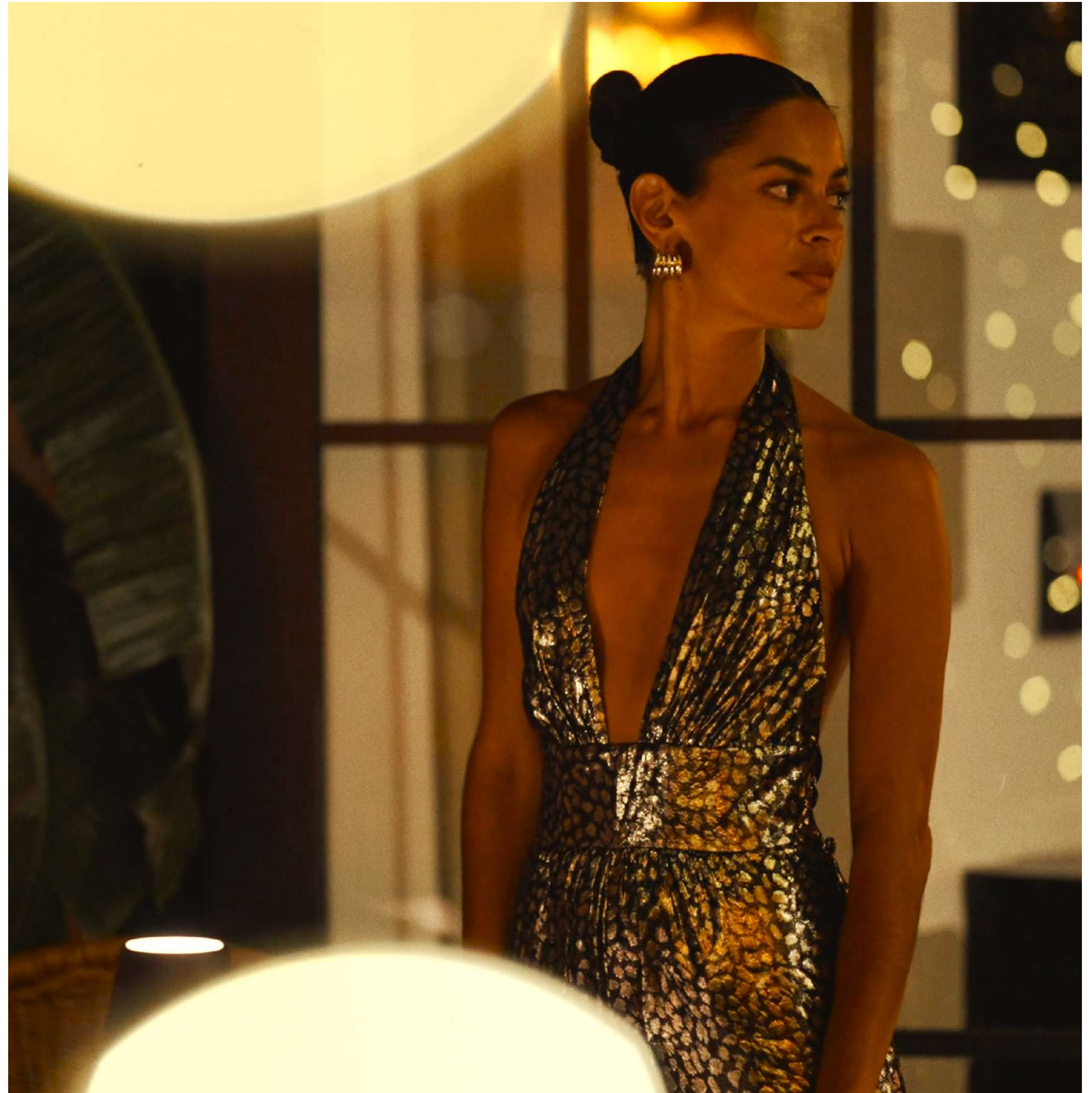
MIAMI'S FIRST-EVER OBSERVATION DECK
